

# CODE ARBITER FOR ALDI 2023-24 ANNUAL REPORT

## Introduction

As a signatory of the Food and Grocery Code of Conduct (Code) prescribed under the *Competition and Consumer Act 2010* (Cth), ALDI Stores (A Limited Partnership) ABN 90 196 565 019 (**ALDI**) is required under the *Competition and Consumer (Industry Codes – Food and Grocery) Regulation 2015* (**Regulation**) to appoint a Code Arbiter in relation to the Code.

On 3 October 2020, when the amendments to the Code came into effect, I was appointed by ALDI as its Code Arbiter.

## Annual reporting requirements

As the Code Arbiter for ALDI, I am required under the Regulation to prepare a written report in respect of each financial year. This is the fourth consecutive year I have prepared an annual report in the capacity of Code Arbiter for ALDI.

Clause 36D of the Regulation outlines the content requirements of the report by the Code Arbiter.

## Time frame

The Code Arbiter for ALDI is required to prepare the report and give copies to ALDI, the Australian Competition and Consumer Commission (**ACCC**) and the Independent Reviewer within 30 business days after the end of each financial year.
